SCRP Resolution: Oppose SHB 2368 Facilitating the Immigrant Industrial Complex

Requesting all Washington State Legislators take legislative actions to require Dept. of Fish & Wildlife and Commission to stop elk intrusion damages and the spreading of the deadly elk hoof rot on Eastern Skagit County's agriculture floor and private property a mandate of RCW77.04.012.

WHEREAS, 85 elk exposed to the deadly elk hoof rot disease in the Mt.St. Helens Herd were imported into Eastern Skagit County in 2003-05, and

WHEREAS, elk hoof rot disease thrives in wet soils and is spread from field to field and from elk to livestock, and

WHEREAS, right now an estimated 300 elk in Eastern Skagit are infected with this inhumane, incurable death sentence by extreme pain, starvation and dehydration, and

WHEREAS, Fish and Wildlife Dept. are unable to respond to eliminate diseased elk in a timely manner, and

WHEREAS, Fish and Wildlife must be held accountable and liable for animal cruelty and inhumane treatment of the states elk, and

WHEREAS, elk intrusion damages are causing over \$1,500,000 damages annually to Eastern Skagit County (Skagit County Assessor Survey 2019) agriculture farms, and

WHEREAS, elk feces contamination is eliminating fresh and organic food production causing food safety and security issues on 13,500 acres of prime farmland, with 6 crop farmers already having to exit Eastern Skagit, and

WHEREAS, elk are causing traffic collisions on state and county roads, and

WHEREAS, a wildlife overpass will not work in Eastern Skagit County. Skagit County is to flat with many private driveways, no natural barriers to channel elk, will only keep elk on agriculture farmland and critical areas wetlands, and

NOW, THEREFORE, IT IS HEREBY RESOLVED, that Fish & Wildlife Dept. and Commission and Director be held accountable for the mismanagement of the imported elk as mandate in RCW77.04.012. The safety and welfare of the citizens of Skagit County has been jeopardized by elk intrusions and now the safety and welfare of the elk themselves is in jeopardy with the spread of the contagious elk hoof rot disease.

Solutions,

- 1. Reinstate the general hunting season a Goal of the 2002 North Cascade Elk Herd Plan which would encourage the elk to move off the agriculture floor back onto a healthier higher dryer elevation. The original intent was to release the imported elk onto state and federal lands in the higher elevations.
- 2. Allow landowners and hunters to euthanize diseased or disabled elk without fear of being penalized and report to Fish and Wildlife for directions with the carcass.
